

Submitting a Working with Children (WWCC) Exemption Request

Coach and managers who are either under the age of 18years old at the time of registration or who are coaching and managing teams where all players are over the age of 18years old are required to submit a WWCC exemption request.

This can be done either during the coach/manger registration process when prompted or separately.

During registration

Select product and start the registration process.


